- 8) Addressing the problems the poor encounter to access, sustain and receive holistic (body, spirit and mind) healthcare when they live in under-resourced communities
- 9) Field-based solutions, appropriate care for malnutrition diabetes and methods that are practical, feasible, inexpensive, and culturally appropriate for treating diabetes
- 10) The applicability, needed resources, lessons learned from PAACS and procedures necessary to implement a general surgery program in other parts of Africa similar to the Pan-African Academy of Christian Surgeons (PAACS)
- 11) Skills to practice surgery on a mission field
- 12) Mobilizing health care volunteers to develop and work together to sustain and build on their prior successes
- 13) Developing family medicine residency training programs and practicing healthcare suitably in creative access countries
- 14) Effectively diagnosing and caring for cardiac patients under the constraints of limited resources
- 15) Making ethical decisions concerning allocations of limited resources of time, supplies and equipment, issues with bribes and deciding whether to provide better access at a higher cost to those who can afford it
- 16) Using the newer vaccines, providing information on illnesses and instructions on injuries for the travelers in developing countries

- 17) Individual parasites, their life cycles, clinical presentations, and treatment
- 18) Clinical approaches for acute and chronic diarrhea in resource-limited settings
- 19) Intervention for children with cerebral palsy and spina bifida in developing countries with limited resources
- 20) Implementation, funding, and cultural issues surrounding how to best utilize the new developments for HIV
- 21) Using the most recent best practices for the care of children with malaria
- 22) Diagnosing and treating tropical diseases and abdominal pain unique to the tropics
- 23) The epidemiology of mental health disorders in the context of cross-cultural settings
- 24) The Community Health Model village
- 25) The symptoms and treatment options for tropical pyomyositis, acute and chronic osteomyelitis and septic arthritis for patients in developing countries
- 26) Cultural implications of Islam and the implications of managing the health of Islamic patients
- 27) Using the ten steps of WHO when diagnosing macronutrient malnutrition (protein-energy malnutrition)
- 28) The major causes of blindness and low vision and what can be done to combat blindness and low vision
- 29) Provide examples of stories and ask thought-provoking questions that stimulate discussion of stories among patients and as teachers
- 30) Recognizing oral lesions can present clues of a systemic disease by their appearance, the character, the size, the duration and their location
- 31) The epidemiology & economically appropriate, biological, psychological, social and spiritual aspects of management for depression and anxiety in developing countries
- 32) Skills in leadership principles managing a staff, starting programs, working with church leaders and sharing a vision that others will follow and support
