What Should the People Do in USA States Before and After Roe v. Wade Overturn

What should the people of God do in each state within the United States, before and after the anticipated action of the U.S. Supreme Court next month overturning *Roe* v. *Wade*? What should bishops, pastors, priests, and churches do? What should pro-life/family ministries and organizations do? What should government lawmakers and officials do? (The USA map of state policies related to abortion and impact of overturning *Roe* was created by National Right to Life: <u>https://www.nrlc.org/uploads/communications/factsheet_postroe.pdf</u>.)To break the power of this great evil over our nation, and to see state governments empowered to end abortion within their jurisdiction, will require first a great humbling of God's people.

Now is the time to face the truth about abortion and what we have done or tolerated in our communities, states, nation, and worldwide. Abortion is the Greatest Genocide in the United States and worldwide. The innocent blood of more than 63 Million Babies in the USA, and 1.1 Billion Babies worldwide, cries out continually to God Almighty, day and night, until justice is done, or Christ's atonement is applied.

The problem begins with idolatry in our hearts and minds (shaped in part by who we listen to, what we watch), that leads to immorality, that leads to child sacrifice and abortion.

Church: Here are a few recommendations for clergy and churches:

- Learn Biblical Truth about the sanctity of human life and accountability of individuals and nations to God for innocent bloodshed, and an adequate understanding of the history of the states and USA (and other nations) first protecting preborn children and later authorizing abortion. - 2. Teach the same to your congregation through one or more sermons. [If you want me to speak in person or by Zoom, I may be available.]
- 3. Call the entire congregation to humbling themselves, prayer, fasting and repentance for sins of idolatry, immorality, and abortion for personal sins and identificational repentance for your community and state, and our national sins.
- 4. For post-abortive men and women, and anyone involved in abortion in any way, call them to repentance and confession so that Christ's atoning blood covers their sin, to restore broken relationships, and offer them compassionate prayer and counseling.

5. Pray for and lobby your civil government representatives to enact laws and policies to protect preborn babies from conception or fertilization and their pregnant mothers by prohibiting abortion.

Pro-life/family: Here are a few recommendations for pro-life/family leaders & organizations:

- 1. If you don't already know, get the AWR and graphs and learn the same information.
- 2. Communicate the same and share your materials with clergy and churches. [If you want me to speak in person or by Zoom, I may be available.]
- 3. Coordinate with churches in educating members and other citizens, and to organize times and events of humbling, prayer, fasting, and repentance.
- 4. Both independently and in coordination with clergy and churches, call post-abortive men and women, and anyone involved in abortion, to repentance and reconciliation.
- 5. Pray for and lobby your civil government to prohibit abortion, as stated above.

Civil government: Here are a few recommendations for legislators and officials:

- To give you a 200-year historical, global, national, and state perspective, and a Biblical understanding of the sanctity of human life, abortion, innocent bloodshed, and how God deals with nations, get the AWR and your state and USA graphs from GLC, and information from state and national right to life and family policy organizations.
- 2. Communicate the same to staff, legislators, officials, and in your public statements.
- 3. Lawmakers: prepare a presentation and speak before the appropriate committees and entire chamber. [If you want me to speak in person or by Zoom, I may be available.]
- 4. Draft a law prohibiting abortion in all circumstances from conception or fertilization.
- 5. Meet with citizens to gain their counsel, wisdom, encouragement and support in the drafting, provisions and passage of the law, and enact the new policy into law.

Please pray for clergy and churches, pro-life/family leaders and organizations, citizens, and government leaders, legislators and judges in each state to have courage to stand and speak the Truth and Words of God, to defend the sanctity of human life, and to end abortion. Also, keep praying for each member of the U.S. Supreme Court, their families, clerks and staff, including for their safety and protection. Pray also that the majority of justices will be strong and courageous and do what they know is right in overturning *Roe* v. *Wade*.
