U.S. Supreme Court Overturned *Roe v. Wade*; GLC Publishes State Abortion Policies

Today, 24 June 2022, the U.S. Supreme Court overturned both *Roe v. Wade* and the later *Casey* case that arbitrarily imposed abortion on demand on the entire nation. The Court held: “The Constitution does not confer a right to abortion; *Roe* and *Casey* are overruled; and the authority to regulate abortion is returned to the people and their elected representatives.”

- USA Abortions Graph, 1951-2021: 63,292,000 Babies Aborted.
- Table 2: States Ranked: Highest to Lowest Total Number of Abortions.
- Table 3: States Ranked: Abortions as % of Current Population.
- Graphs 1 & 2: Abortion Rate & Number Trends & Impact of *Roe v. Wade*.
- Graphs 3 & 4: Missouri & Texas: impacts of restrictions on abortion.
