President Trump Enacts 3 Pro-Life Measures

On Friday, 24 January 2025 – the day of the 52nd annual March For Life in Washington, DC – President Donald Trump signed three pro-life executive orders.



1. **Restored [The Mexico City Policy](#):** President Trump issued a Memorandum to “reinstate the Presidential Memorandum of January 23, 2017 . . . (The Mexico City Policy).” The Memorandum was addressed to “the Secretary of State” (foreign affairs), “the Secretary of Defense” (the military), “the Secretary of Health and Human Services” (domestic and international health policy and programs), and “the Administrator of the United States Agency for International Development” (foreign aid and programs). It included a directive to “the Secretary of State . . . to ensure that U.S. taxpayer dollars do not fund organizations or programs that support or participate in the management of a program of coercive abortion or involuntary sterilization.”

The 2017 Presidential Memorandum was the “Protecting Life in Global Health Assistance” (PLGHA), which reinstated the Mexico City Policy that former President Obama revoked, and which former President Biden also revoked on his first day in office. The 2017 Trump PLGHA policy directs “that no U.S. taxpayer money should support foreign organizations that perform or actively promote abortion as a method of family planning in other nations.” Thus, [75 million](#) in funding to International Planned Parenthood and Marie Stopes International will now be cut off.

2. **Restored The Hyde Amendment:** President Trump signed an Executive Order “[Enforcing the Hyde Amendment](#).” The Hyde Amendment and similar laws . . . prevent Federal funding of elective abortion, reflecting a longstanding consensus that American taxpayers should not be forced to pay for that practice.”

3. **[Pardoned 23 Pro-Life Advocates](#):** President Trump pardoned 23 pro-life advocates, declaring, “They should not have been prosecuted,” and, “This is a great honor to sign this.”

In addition, the Trump Department of Justice restored sanity and justice to the enforcement of “the Freedom of Access to Clinic Entrances (FACE) Act”: They ended “[the weaponization of the federal government](#)” against peaceful pro-life protesters, and ordered the permanent dismissal of “three FACE Act cases.”

THANK YOU President Trump for protecting the sanctity of human life from its beginning, and for restoring righteousness and justice to our Federal Government.

PRAY: Give thanks to the LORD and Ruler of nations – for Whom “righteousness and justice are the foundation of (His) throne” (Psalm 89:14) – for these decisive actions that are restoring some measure of righteousness and justice to the United States. Pray for faith, courage, boldness, endurance and tenacity for President Trump and his Administration to stay on course, make hard decisions and wise policies such as these, and enforce them.
